B) Flying insects, fleas, bedbugs or any other pest not specifically listed shall incur a separate charge if requested by the customer.

C) Any rodent proofing or other mechanical alterations found to be necessary can be done at additional cost to the customer. Authorization for additional work of this type will be on a separate agreement.

D) \*Spiders are difficult to control. They must have direct contact with pesticides in order to be exterminated. Generally, THE BUG TERMINATORS, LLC will treat isolated spider infestation at no additional cost. However, major spider infestation, which involves; removal of large amounts of spider webs, accessibility issues, and any other obstacles found to be overwhelming to the technician will incur a separate charge - if requested by the customer. For more information on this matter please contact our office.

E) Special or One Time Service will only carry a 30 day retreatment guarantee, unless otherwise specified in this agreement.

### 3) CUSTOMER PARTICIPATION:

A) Pest management includes the application of pesticide materials and devices (the responsibility of THE BUG TERMINATORS, LLC) along with the maintenance of sanitation and the mechanical pest proofing of the building (the responsibility of the CUSTOMER).

B) To this end, the THE BUG TERMINATORS, LLC technician shall prepare a Pest Management Report, such as that submitted with this agreement, after each service and it is to be signed and retained by an authorized agent of the customer. The CUSTOMER agrees that conditions reported therein as being inconsistent with good sanitation and effective mechanical prevention will be corrected immediately. Failure to cooperate in the correction of these conditions may cause THE BUG TERMINATORS, LLC to give 30 days notice of intent to cancel and void this agreement and any guarantees stated herein.

7) SPECIAL INFORMATION, FIRST SERVICE: Heavy Spider webs treatment, treat ext around buildings and common areas. Treat int as needed. wipe spider webs

8) SPECIAL INFORMATION, MAINTENANCE: Bi-monthly Service - treat ext, wipe spider webs, int as needed.

9) SEE SERVICE TREATMENT DURING CUSTOMER ABSENCE INFORMATION ON REVERSE SIDE: By initialing here customer has agreed to this clause. Customer initials: x
